TRAVEL INFORMATION
HOW TO GET TO THE UNIVERSITY OF WASHINGTON
MCCARTY, HANSEE, HAGGETT, MCCARTY, AND HANSEE RESIDENCE HALLS

FROM SEATAC AIRPORT

Taxi: Approximately \$35 - \$45. Ring bell outside baggage area passenger loading zone for taxi dispatch.
(Approximately 20 miles to UW)

Shuttle Express Service: (425) 981-7000 (within Washington) or 1-800-487-7433 (toll free). Please see signage at the airport for the current location. Door-to-door 24-hour service. The cost is \$25.00 per person one way. Advance reservations are required on trips returning to SeaTac.

METRO Bus: (206) 553-3000 \$1.25-\$2.00 depending on the time of day. Exact change is required. Board bus #194 or, after 8:30 p.m., #174 northbound to downtown Seattle from Bay 2. Look for the sign outside the baggage area. The trip will be approximately 25-30 minutes. When boarding, pay fare and request a transfer pass. Exit the bus at 2nd and Pike, walk 0.1 mile North to 3rd and Pike, and transfer to bus #71, #72, or #73. Exit the bus at Campus Parkway and Brooklyn, and keep your transfer pass handy. Walk 100 feet east to Bay # 2 and get on bus #65, #75, or #372. Show the driver your transfer pass as you board.

Entering the main gate onto campus, the bus will turn left onto Stevens Way at the first intersection. At the fourth campus stop (in front of Padelford Hall), exit the bus. Just across the street will be Clark Hall. Walk north along Stevens Way, passing Pend Oreille Rd. on your right. Continue straight onto Whitman Court. The first building on the right is McMahan Hall, followed by Haggett, McCarty and Hansee Halls (in that order).

DRIVING

Via Interstate-5: Take Exit 169, NE 45th St. and turn east (right if traveling northbound, left if traveling southbound) onto 45th St. Travel east on NE 45th St. to 17th Ave NE and turn south (right) onto campus. Stop at the parking gate to purchase a permit if it is open, or proceed to Stevens Way and turn east (left). Follow Stevens Way until you reach Whitman Court (to the left). After turning left onto Whitman Court, you will find McMahan, Haggett, McCarty and Hansee Halls (in that order) on the right-hand side of the road. Please note all parking on campus is restricted to paid permits all days except Sundays and holidays.

Construction: During Summer 2006 Stevens Way will be under ongoing construction. For ease of travel, we recommend the following detour: After turning east on NE 45th St, travel to 15th Ave NE and turn south (right). Merge into the left lane. Proceed down 15th Ave NE. Turn left (east) onto 40th Street NE and onto campus. Stop at the parking gate if it is open, or proceed up the hill and turn right at the first Stop sign. Follow Stevens Way until you reach Whitman Court (to the right). You will then proceed onto Whitman Court as stated above.
