United will provide to passengers traveling to attend the Meeting(s) defined above ("Meeting Travelers") round-trip transportation on scheduled service to the Meeting City(s) on United, United Express, TED by United, or United code share flights (UA\*) operated by US Airways, US Airways Express and Air Canada (\*\*no other code share flights unless otherwise specified) for travel in or between the the United States, Canada, Caribbean, San Juan, US Virgin Islands and Mexico Beaches at fares at either (1) a 2% discount off Q, V, W, S, T and L published fares in effect when the tickets are purchased subject to all restrictions and rules applicable to the fare purchased, or (2) a 5% discount off applicable M, E, U, H fares in effect when tickets are purchased subject to all restrictions and rules applicable to the fare purchased, or (3) a 10% discount off applicable F, A, P, C, D, Y and B fares in effect when tickets are purchased subject to all restrictions and rules applicable to the fare purchased. For tickets purchased **more than 30 days** prior to travel within the contracted Travel Period the following discounts apply: 7% discount off Q, V, W, S, T and L published fares, or (2) 10% discount off applicable M, E, U, H fares, or (3) a 15% discount off applicable F, A, P, C, A, D, Y and B fares
- B. Productivity Tickets If at least 40 Meeting attendees travel to the Meeting City on United (Meeting Travelers), 1 complimentary coach class ticket(s) will be provided for every 40 Meeting Traveler(s). Productivity tickets that are sold, bartered, or transferred will become void and certain blackout periods apply. Productivity tickets are valid for travel to the meeting city or anywhere on United's system in the 48 contiguous states, Canada and Puerto Rico. All travel must be completed by 1 year from date of issue.
